### **APPLICATION SCHEDULE:**

**Application deadline:** Sprg - Feb 15, Fall - Jun 30

**Space confirmed/payment due:** Sprg - Mar 10, Fall - Jul 31

**Unpaid spaces released:** Mar 15, Fall - Aug 9

**Space map available:** Apr 10, Fall - Sep 6

### **SET UP:**

Your set-up space will be clearly marked for you on the grounds. The areas are grassy, and some are shaded.

Your 10'x 10' space will be marked. You are responsible for your own set up, staffing, tent, etc. We will have a team of haulers/helpers here working on set-up day. As time allows, they may be available to assist you. If you use their help, **be sure to tip them.**

In case of damp ground, you may want to bring pallets to create a raised floor for your space using wafer board or plywood.

Be prepared with plastic sheeting and/or tarps to cover your merchandise over night.

## **DURING THE SALE:**

We have a team of haulers to help haul and load furniture for customers. As time allows they may be available to bring items from your vehicles. If you use their help, **be sure to tip them.**

## **INTRA-DEALER SHOPPING:**

You are welcome to shop and trade among each other during set-up and after the sale. However, during sale hours, while customers are here, please be discreet about this.

## **THE WAY IT WORKS:**

All of your sales are your own responsibility, including wrapping items and any sales tax remittance.

Be sure to provide some proof of purchase for your customers, such as bags, receipts, SOLD stickers, etc.

Customers must make arrangements to remove items directly from you. **There is no holding area available here at Chartreuse.**
